

Federal Labor Laws by Number of Employees

This chart identifies federal labor laws that apply to an employer based on its total number of employees. Several other factors may apply in determining employer coverage, such as whether the employer is public or private, whether the employer offers health insurance and whether the employer uses a third party to conduct background checks. Employers should review the laws to determine other criteria that may apply in determining employer coverage. Each requirement may have other coverage criteria that should be reviewed against the specific contract.
